**WHEREAS**, the Department has determined that the amount of funds to be paid to the Contractor is fair and reasonable to provide such services; and

**WHEREAS**, a copy of this agreement is on file with the Clerk of the Board of Supervisors;

**WHEREAS,** Community Action Program, Inc., receives funding to operate other low-income housing initiatives and credit counseling services; and

**WHEREAS,** total (100 percent) federal funding of \$108,948 is available through the Office of Temporary and Disability Assistance to provide these services; and

**WHEREAS**, a copy of this agreement is on file with the Clerk of the Board of Supervisors;

### RECOMMENDING A STUDY FOR CHANGING THE HEALTH INSURANCE BENEFIT POLICY IN 2010 FOR MADISON COUNTY ELECTED OFFICIALS AND MANAGEMENT EMPLOYEES

**WHEREAS**, the Madison County Board of Supervisors is charged with the ultimate responsibility for establishing policies governing salary and benefits for all elected officials and management employees, and

**WHEREAS**, the Madison County Board of Supervisors has the opportunity to enact policies that reflect a growing awareness of the high unemployment and troubled economy locally, regionally and statewide and a willingness for setting

the example of shared sacrifice in light of these difficult economic times for many local residents and property owners, and

WHEREAS, nearly one fourth of all Madison County residents are receiving some kind of public assistance in the form of Food Stamps and Medicaid during this current economic crisis while high unemployment continues, and

WHEREAS, elected officials and management employees have enjoyed the benefit of free individual and family medical insurance paid for by county taxpayers as one of the benefits of being a Madison County employee, and

WHEREAS, the rising cost of health care, the troubled economy and the fiscal crises in Albany and Washington call for a shared sacrifice to set the tone locally and to establish both a positive example for other municipal employees and officials to follow while reducing the 2010 Madison County budget and future county budgets accordingly, and

**WHEREAS,** a 10 percent cost sharing in county health insurance costs by elected officials and management could save Madison County approximately \$100,000 annually, and

**WHEREAS,** Rules 16 and 17 of the Madison County Board of Supervisors, along with County Law, make it unclear if a reduction in compensation of elected officials can be enacted during annual session and would require legal review by the Madison County Attorney,

NOW THEREFORE BE IT RESOLVED, that the Board of Supervisors requests that the County Board Chairman, County Budget Officer and County Treasurer collaborate with the Government Operations committee in 2010 to provide information to the full board on the current cost of free health insurance provided to elected officials and management staff, in order to allow the full board to consider a policy change in 2010 that would require all elected officials and county management employees to pay 10 percent of the cost of their health insurance premiums through payroll deduction in order to demonstrate a shared sacrifice to the county taxpayers, reduce county expenditures and also encourage other municipal employees and officials to join in this effort in 2010, and

**BE IT FURTHER RESOLVED,** that the Board of Supervisors, in consultation with the Board Chairman, Budget Officer, County Treasurer and County Personnel Department, develop a stipend incentive plan similar to that offered to county employees and other municipalities that would encourage those elected officials and management employees who can acquire health insurance through other employed family members to do so in order to advance further costs savings in 2010 and future years, and
